WHEREAS, autism spectrum disorder, or ASD, is a complex developmental disability that typically appears during the first three (3) years of a child’s life and affects their ability to communicate and interact with others; and there is no single cause for ASD, but increased awareness and funding can help families today; and

WHEREAS, autism is defined by a certain set of behaviors and is a “spectrum disorder” that affects individuals differently, to varying degrees, and it knows no racial, ethnic, or social boundaries; and

WHEREAS, the U.S. Centers for Disease Control and Prevention’s Autism and Developmental Disabilities Monitoring Network found that one (1) in thirty-six (36) children were identified with ASD based on tracking across multiple areas of the United States. This same data revealed that some characteristics of children with ASD have remained the same, and that boys were almost four (4) times more likely to be identified with ASD than girls. Today, one (1) in twenty-five (25) boys and one (1) in one hundred (100) girls, or one (1) in thirty-six (36) children, will be diagnosed with autism spectrum disorders; and more children are diagnosed with ASD than childhood cancer, juvenile diabetes, and pediatric AIDS combined; and

WHEREAS, the U.S. CDC reports the likelihood of a school-aged child receiving a diagnosis of autism, or a related developmental disorder, rose more than seventy percent (70%) since 2012. The report also stated that approximately one (1) in thirty-six (36) children in the nation are diagnosed with autism today, an increase from one (1) in one thousand (1,000) in 1980; and

WHEREAS, on average, autism costs an estimated Sixty Thousand Dollars (\$60,000) a year through childhood, with the bulk of the costs in special services and lost wages related to increased demands on one (1) or both parents; and costs increase with the occurrence of intellectual disability. The cost of caring for Americans with autism had reached \$268 Billion Dollars in 2015 and would rise to \$461 Billion Dollars by 2025 in the absence of more effective interventions and support across the life span of individuals with autism; and

WHEREAS, caring for a child with ASD can place a heavy economic burden on families and communities. The ADDM Network estimates that it costs at least Seventeen Thousand Dollars (\$17,000) more per year to care for a child with ASD, as compared to a child without ASD; and costs include health care, education, ASD-related therapy, family-coordinated services, and caregiver time. Taken together, it is estimated that the total societal costs of caring for children with ASD was more than \$11.5 Billion Dollars in 2011; and

WHEREAS, the latest report from the U.S. CDC finds that 1.47% of eight (8) year old children have autism. Extrapolating this rate to all people with autism puts costs at roughly \$358 Billion Dollars in 2015 and \$616 Billion Dollars in 2025. Assuming autism rates will continue to climb, as they have over the past few years, lifts the 2025 estimate to more than \$1 Trillion Dollars; and

WHEREAS, a quarter century ago, a nationwide effort was launched to promote autism awareness, inclusion, and self-determination for all, and ensure that each person with ASD is provided with the opportunity to achieve the highest possible quality of life; and this year, the Autism Society wants to go beyond simply promoting autism awareness by encouraging friends and collaborators to become partners in the movement towards acceptance and appreciation; and

WHEREAS, the Autism Community Together (ACT), which was formed in January 2004, has continued to spearhead an awareness effort to educate parents, professionals, and the general public about autism and its effects; and a Run for Autism, an Autism Awareness Fair, and other events are being coordinated throughout the month of April 2025 during the observance of “Autism Awareness Month” with its theme: “Autism is Life-Embrace the Journey!”; and

WHEREAS, in order to highlight the growing need for concern and awareness about autism, the Autism Community Together (ACT), parents and family members, support groups, researchers, and professionals have dedicated years of service in their ongoing efforts to advocate for the rights, respect, dignity, humane treatment, and appropriate education in support of all persons with autism; now therefore, be it

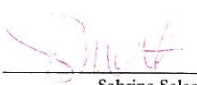
