1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2        ***MINA'TRENTAI OCHO NA LIHESLATURAN GUÅHAN:***

3        **WHEREAS,** the Guam Memorial Hospital Volunteers Association (GMHVA)  
4        is a non-profit organization founded in 1965 by the late Senator Cecilia “Chilang” Cruz  
5        Bamba with the mission of supporting the Guam Memorial Hospital Authority  
6        (GMHA), Guam’s only civilian hospital, through the operation of the Gift Shop and  
7        Gift Cart, provision of patient care and interpreter services, and fundraising efforts to  
8        procure durable medical equipment, furnishings, fixtures and essential services; and

9        **WHEREAS,** over one hundred and thirty (130) dedicated volunteers have  
10        generously contributed their time, talent, and personal resources, raising in excess of  
11        Ten Million Dollars (\$10,000,000) since the founding of GMHVA in April of 1965,  
12        thereby substantially enhancing the quality of care and comfort provided to patients of  
13        GMHA; and

1           **WHEREAS**, Teresita S. Delos Reyes was selected as the 2024 Volunteer of the  
2 Year in recognition of her exemplary service, having amassed over two thousand, three  
3 hundred (2,300) volunteer service hours since becoming a member in 2018; and

4           **WHEREAS**, over the past seven (7) years, Mrs. Delos Reyes has distinguished  
5 herself in numerous capacities, including as a cashier and shift leader at the GMHA Gift  
6 Shop, and as an active member of the Thanksgiving Raffle Committee, Christmas  
7 Bazaar, Christmas Caroling troupe, Three Kings Celebration at the Skilled Nursing  
8 Unit, Awards and Recognition Banquet planning team, Membership Tea host, and in  
9 direct patient visitation; and

10          **WHEREAS**, in her ongoing role as Gift Shop cashier and shift leader, two days  
11 per week, Mrs. Delos Reyes has demonstrated exceptional competence and reliability –  
12 servicing customers, pricing and stocking merchandise, maintaining inventory records,  
13 and executing additional duties with focus and diligence – thereby ensuring  
14 uninterrupted operation of this vital service to the hospital community; and

15          **WHEREAS**, in 2024, Mrs. Delos Reyes further served on the GMHVA  
16 Executive Board as Member-at-Large, chaired the Finance Committee for the annual  
17 Charity Ball, and led the Membership Committee, overseeing the engagement of one  
18 hundred and thirty (130) volunteers while mentoring prospective members; and

19          **WHEREAS**, the passion and commitment of Mrs. Delos Reyes to GMHVA’s  
20 mission are further bolstered by the steadfast support of her husband, Nito, and her  
21 children and their family: Gerard and Kimberly, Tricia and Shawn, Nito, Jeremiah, and  
22 Nicolo; now therefore, be it

23          **RESOLVED**, that the Committee on Rules of *I Mina'trentai Ocho Na*  
24 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
25 of Guam, recognize Teresita S. Delos Reyes upon her selection as the 2024 Volunteer  
26 of the Year by the Guam Memorial Hospital Volunteers Association (GMHVA), and

1 further commend her exemplary service, leadership, and unwavering dedication to the
