

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI OCHO NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, Linda Simon has been an active, with good standing, member of  
4 the Guam Memorial Hospital Volunteer Association (GMHVA) since 2009; and

5           **WHEREAS**, since joining in 2009, Linda has dedicated her time to working at  
6 the Hospital Gift Shop every Monday and Wednesday morning. A year later, she  
7 became a key member of the Point of Sale (POS) system team, contributing countless  
8 hours to ensure its efficiency; and

9           **WHEREAS**, Linda has met the requirements and prestigious honor of Lifetime  
10 Membership Award with 15 years of service, and over 5,000 hours of dedicated  
11 volunteer service as a member of GMHVA; and

12           **WHEREAS**, Linda was nominated and elected to serve as Secretary of the  
13 GMHVA Executive Board for two consecutive years, where she provided outstanding  
14 service and creative initiatives that resulted in high sales for projects such as the silent

1 auction at Charity Balls and the raffle and solicitation project from the Thanksgiving  
2 fundraising event; and

3 **WHEREAS**, Linda was involved in the many different volunteer roles in the  
4 capacity as a committee or participating member in the various programs and  
5 fundraising projects of GMHVA to include Membership Drive Tea, Installation of  
6 Officers, Volunteer Recognition Ceremony, Bake Sales, Rummage Sales, etc.; and

7 **WHEREAS**, in recognition of her outstanding performance and dedicated  
8 service, Linda was nominated and voted as the “2017 GMH Volunteer Association  
9 Volunteer of the Year” by the membership of GMHVA; and

10 **WHEREAS**, In recognition of her achievement as Volunteer of the Year, Linda  
11 received a “Certificate of Commendation” from Senator Dennis G. Rodriguez, Jr. in  
12 2017; and

13 **WHEREAS**, upon contributing more than 4000 volunteer hours to GMHVA,

16 Program; and

21 **WHEREAS**, Linda has been volunteering with the Guam Diabetes Association  
22 since 2010, serving on the Executive Board as an Auditor for 12 years and participating  
23 in various community outreach initiatives; and

24 **WHEREAS**, in 2012, Linda was installed and currently serves as an  
25 Extraordinary Eucharistic Minister at Santa Barbara Church in Dededo. She was  
26 recommissioned on April 13, 2017, to continue her commitment to serving our Catholic  
27 Church; and

1           **WHEREAS**, Linda received a “Certificate of Special Congressional  
2 Recognition” from Congresswoman Madeleine Bordallo for her exemplary  
3 commitment to community service; and

4           **WHEREAS**, in 2018, Linda served as a member of the Finance Committee for  
5 the 53<sup>rd</sup> Charity Ball Anniversary, overseeing ticket sales, boosting sales and ensuring  
6 accountability; and

7           **WHEREAS**, Linda was recognized as a “COVID-19 Hero” by GMHVA in 2022  
8 for her selfless contributions that made a lasting difference during the pandemic; and

9           **WHEREAS**, prior to joining GMHVA, Linda worked for 30 years as an IT  
10 Operations Manager for Duty Free Shoppers, LTD; and

11           **WHEREAS**, Linda is married to Gonzalo V. Simon Jr., and they have three  
12 children: Lea, Geoffrey, and Leslie. They are also blessed with four grandchildren:  
13 Leizllyn, Tobie, Gabriel, and Lorelai, all residing in Seattle, WA; now therefore, be it
