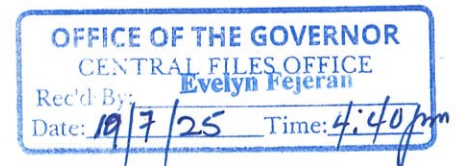
1. The Legislature did consent to the Executive Appointment of Anita Borja Enriquez, DBA to serve as a Member of the Guam Land Use Commission.
