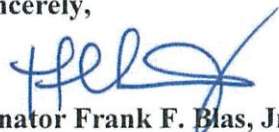

8. The Legislature did consent to the Executive Appointment of Gerald P. Yingling to serve as a Member of the Guam Land Use Commission.

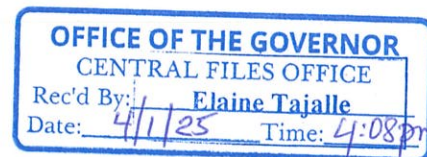

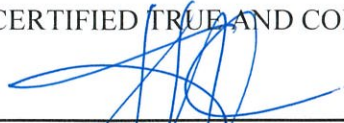
